## **Spring Membership Event Very Informative!**

Mr. Kronemeyer graciously spent the evening addressing League members and guests on the subject of the links between transportation and land use. His presentation was well-researched and illustrated principles important for the public and elected officials to consider when making decisions about either transportation or land use. Mr. Kronemeyer noted that it is important for the citizens of the San Joaquin Valley to carefully consider the future we envision for our region and how the decisions that are made support or undermine that vision.

An early point Mr. Kronemeyer made is that when highways are extended or widened through undeveloped areas, the effect is to make the undeveloped areas available for new development, enlarging the developed area and creating congestion on the new highway. Interestingly, removing highways had not been shown to increase congestion. Highways have been removed by disaster (Embarcadero Freeway in San Francisco) and deliberately (San Francisco and Milwaukee) with no adverse effects; in fact, the surrounding areas have once again welcomed pedestrians, transit, and motorists, instead of only being used by motorists.

Supporting this idea, Mr. Kronemeyer demonstrated how limited access roadways, such as freeways and expressways, are actually able to carry less traffic than well-connected street networks, such as those found in older downtown areas. Well connected downtown networks were built before automobiles were available or common, so most people traveled on foot, bicycle, or streetcar. Shorter blocks made it easier for people to reach their destinations on foot-and are also more efficient for automobile traffic. Ironically, as cars have become very common, so have limited-access roadways, which less effectively serve both motorists and pedestrians. Further, the high speeds on these types of roadways are designed to increase the speed at which motorists drive, decreasing safety.

Mr. Kronemeyer went on to discuss land use patterns: before automobiles, daily needs were within an easy walk of every home. After cars, and particularly after World War II, land uses have become increasingly separated from each other, forcing people to drive to satisfy almost all of their needs. But for people too young or too old to drive,

## MEETING 2007

### Program Planning & Gang Consensus Meeting

The annual Program Planning meeting was held on February 13<sup>th</sup> in conjunction with the Gang Study Consensus meeting. Ten members attended the meeting. The meeting was opened with a review of the Gang Study Committee findings presented by Maria Arevalo. After some discussion the members in attendance came to the following consensus and at the March 14<sup>th</sup> Board meeting it was recommended we adopt this position:

*“In order to address the problem of criminal gang activity within our community, we support the development of culturally diverse intervention and enrichment programs at the elementary school level and beyond.*

*A. Such programs may include recreational, athletic, academic, creative and/or social activities.*

*B. We encourage allocation of resources to fund these programs through public, private and/or non-profit organizations.”*

Laurie Carley opened the program planning meeting at 8:00 and our state and local positions were discussed. The ten members present and the three mail-in responses concurred that we retain all current state positions. The membership did not recommend a state study at this time. We agreed that our local priorities for state issues for Education and Advocacy should be: Redistricting, Water, and Air Quality.

We also agreed to retain our local positions as our local action committee chaired by Marie Bairey has utilized them. It was moved by Marie Bairey and seconded by Maria Arevalo that we recommend a local study on the *“Election of Municipal Officials by District”*. This proposed study would be voted on at the Annual Meeting on Saturday, May 5<sup>th</sup>.

In addition, it was recommended that our local program positions be edited to reflect the change in our name from *“League of Women Voters of Modesto”* to the *“League of Women Voters of Stanislaus County”*.

Thank you to all who participated in our program planning process and the Gang Study and Consensus.

## LOCAL ACTION

### Local Planning Recommends Study

At Annual Meeting, LWVSC members will be asked to approve a local study on district election of municipal officials. The Local Action Committee recommended the study which was approved at the State and Local Planning meeting in February and the Board in March.

While discussing issues of interest at the January Local Action Committee meeting, district elections for city council came up. This topic is in the news currently in Modesto because of a pending lawsuit, a local initiative and the work of the City Charter Review committee. Under current City Charter provisions, city council members are elected at large for “chairs”. These “chairs” have no residence requirements. The committee realized that while League has a position on legislative redistricting, the position does apply to election systems for local officials. Without a position, League cannot take action.

If approved by the membership, a study committee will be formed in May to commence work during the summer with the goal of bringing information and possible recommendations back to the members for consensus in September. Members interested in this project, please contact Patty Lundy.

the separation of land uses in this way traps non-drivers in their homes, making them dependent upon others for every need. But we have changed our development pattern from walkable to unwalkable in the last 60 years-even traditional downtowns have been made less walkable.

The good news is that the damage can be repaired. Buildings can be oriented to the street with doors and windows facing the street and parking behind the buildings, inviting pedestrians to walk, while still allowing access by car. Streets with too much commercial and high travel speeds, such as lower McHenry Avenue, can be improved by adding residences oriented toward the street, widening sidewalks, adding trees next to the curb, and reducing lane widths to calm traffic. Mr. Kronmeyer showed the audience excellent photo simulations of projects he has worked on that have taken overly wide, high speed, unfriendly roads fronted with parking lots and changed then into streets fit for people: narrower, lined with trees and buildings.

Ultimately, however, plans are only illustrations and text on paper. Village One has graphically demonstrated for Modestans that implementing good plans requires watchfulness and a sustained effort on the part of the public. Likewise, the "Blueprint for the San Joaquin Valley" effort will require active, sustained public engagement to implement whatever vision is developed for our region. If it should succeed, we can all enjoy that success and share in the credit. If it should fail, that failure will be the public's alone. Education is just the first step.
