LWVSC POSITIONS on MODESTO SEWER EXTENSION BALLOT MEASURES

The League of Women Voters of Stanislaus County continues its interest in land use decisions, especially those involving potential growth into unincorporated areas. We support measures that protect farmland outside defined urban boundaries, protect the quality of our environment, provide development contiguous with existing development, and provide adequate funding for infrastructure.

We have studied the City of Modesto's Measures A, B, C, D, and E, sewer extension advisory measures, on the November 3 ballot. We recognize these areas were identified by the City Council because of their potential for economic development and job creation and that they are contiguous to areas already approved or developed. However, among our concerns is the fact that the City of Modesto in the past has not always followed proposed plans, to the detriment of the city. Also, there is an existing inventory of land already approved but not yet developed, as well as underutilized properties affected by the current economic downturn, which should be developed before more farmland. The City still has no farmland mitigation policy despite promises.

The League's positions are:

- <u>A Kiernan Corridor</u>: No position. With access to Highway 99, improvements to Kiernan Avenue and proximity to Kaiser's new hospital and other business parks, development of this area is well on its way. Our concerns, however, are that the proposal extends north of Kiernan, which otherwise could be a natural barrier or limit to the city's growth, includes prime farmland within the proposed area, would require rezoning hundreds of acres from Village Residential and precedes final determination of the route of the North County Corridor.
- <u>B College West</u>: The League opposes this measure. The Briggsmore/99 interchange is already a transportation nightmare. The Beckwith overpass and frontage road are inadequate to meet the demand. With residential development in the area, how can we be sure the intentions of this Council for business park development will be honored by future Councils? The area includes and is adjacent to prime farm land that should be protected. Annexing this area would open west of 99 to development.
- $\underline{C-North\ McHenry}$ The League supports this measure. This is an opportunity to "clean up" the city/county mix on north McHenry Avenue by bringing the already developed commercial area into the City of Modesto.
- $\underline{D-Tivoli\ North}$ –The League opposes this measure. Annexation is premature. The area is adjacent to the already approved but undeveloped Tivoli neighborhood. Although it has poorer soil and offers opportunity for some commercial development, it is primarily a residential area. Traffic flow in the area is a concern as no infrastructure has been developed, and the route of the North County Corridor is yet to be determined.
- <u>E Hetch-Hetchy</u> The League opposes this measure. This area was not included in the City of Modesto's initial proposal for annexation because it offers limited potential for economic development. Land owners petitioned for an advisory vote, citing the fact that the area is surrounded by current or future development. As with Measure D, it is primarily residential and annexation is premature.

LUNCH AND LEARN

October 27th Lunch and Learn Michael Sullivan, CEO, Golden Valley Health Care

Health care---now there's a term you have heard recently. Please plan to come to the October Lunch & Learn Program. Our speaker will be Michael O. Sullivan, Chief Executive Officer of the Golden Valley Health Centers. He will be speaking on the role of Community Health Care Centers in today's health care world. On September 1, 2009, the Stanislaus County Supervisors voted to reduce funding for health care in our County. According to an article in the Modesto Bee, more than 2,600 of the 6,000 to 7,000 people served by the county's Medically Indigent Adult program will be charged higher co-payments for dental and medical services starting October 1, and some won't be eligible at all.

In a recent guest editorial in the Bee, Mr. Sullivan wrote that Community Health Centers serve as primary points of access to high-quality health care, regardless of a person's insurance status or ability to pay. Community health centers are nonprofit, locally directed providers of primary and preventive health care, dental services, health education and related services to more than 18 million people in the nation. Community health centers were among the first to receive money from the American Recovery & Reinvestment Act (the stimulus), and this money is being used to provide care to more people as they lose their health insurance along with their jobs. Mr. Sullivan goes on to say that the stimulus funding was important at the time, but it isn't the cure. "The cure is health reform done right."

August Lunch and Learn Steve Madison and Bill Zoslocki

Myth Busters - the folks who came to the August Lunch & Learn meeting were presented with a program from the Building Industry Association of Central California (BIACC) concerning land use in our area today. Steve Madison, Executive Vice President of the BIACC, and Bill Zoslocki, past president and owner of Bill Zoslocki Construction Co., Inc., gave a Power-point presentation to a large and interested group pointing out some of the myths surrounding growth issues in our area today.

One example was the assertion that farm revenues in Stanislaus County are at significant risk because of prime farm land loss. That is a myth because the facts, provided by the Stanislaus County Agricultural Commissioner, show that the crop yield in the County in 1997 totaled \$1,316,942, 000, while in 2008, it was \$2,473,843,000 - an 88% increase. Another myth which the presentation "exploded" was that Stanislaus County is losing overall farm land to urbanization. Is there really less farm acreage today? According to the Stanislaus County Agricultural Commissioner again, in 1977, there were 795,000 acres being farmed while in 2008, there were 907,656 in farm use—an addition of 112,656 acres overall.

The presentation discussed the fact that Stanislaus County has fewer high school and college graduates; a higher unemployment rate and a lower median family income than the San Jose area, according to the U.S. Census Bureau data. Mr. Zoslocki said that we should learn from the mistakes San Jose has made and work together to diversify our economy to help mitigate these problems. A lively period of questions and answers and discussion followed. This program was timely, given the studies LWV is currently doing concerning the up-coming Measure M vote.

LWV URGES COPYCAT ORG. TO END MIS-LEADING HEALTH CARE ADS

League of Women Voters Objects to Deceptive Advertising by "League of American Voters"

Washington, DC – In a hand-delivered letter, the League of Women Voters called on the "League of American Voters" (LAV) to "cease and desist" from using a name clearly designed to be confused with the League's in order to disseminate misleading information and block health care reform.

"The League of American Voters health care ad makes misleading statements in an inflammatory way," League of Women Voters President Mary G. Wilson stated in her letter to LAV Executive Director Bob Adams. "Not only does your ad distort the facts on health care reform, it does so using a name that is deceptively similar to the League of Women Voters," Wilson said.

"We are not convinced that this startup group is a credible organization with authority to speak on behalf of American voters," Wilson said. "They may have a legitimate-sounding name, but—until we know who is funding the ads—there is no reason to believe that they are anything other than another organization serving as a conduit for big-money attacks on health care reform."

"This is typical of the kinds of things we are seeing from the opponents of health care reform. Intentionally putting out bad information to mislead, confuse and scare Americans," Wilson charged.

"This copycat group appears to be entirely inaccessible to the public. We had to hand-deliver our letter because the group's website lists no email address or fax number," Wilson said, pointing out that the group's office address is shared with several lobbying groups who were unable to locate LAV management or staff.

"The League is releasing the text of this letter to set the record straight: The work of Mr. Adams' organization should in no way be confused with the League of Women Voters," Wilson added.

"The League of Women Voters of the United States has more than 150,000 members and supporters nationwide, and we are one of the most trusted non-partisan organizations in the U.S. Our members and the public rely on us to share information responsibly and accurately, because that is what we have done for almost 90 years," Wilson said.

"Make no mistake: The League of Women Voters believes quality, affordable health care should be available to all Americans," Wilson stated.

"The League of American Voters would best serve Americans by telling the truth in their ads. Our democracy depends on honest and open debate among real people, not misinformation from mysterious, inaccessible organizations that get money from unknown sources to create national TV spots in order to block needed health care reform," Wilson concluded.
