PRESIDENT'S MESSAGE

Dear Members,

“League’s values are America’s values,” was the message from outgoing LWVUS President Mary Wilson to the 600+ League members attending Convention 2010 in Atlanta in our 90th anniversary year. Our work has never been more important than right now, she stated. People working against our issues are very visible and “we need to be visible too.” After all, these are issues that League members have studied, re-studied and advocated for over a period of years. For example, League members started working on healthcare reform as an issue in 1990. As one former LWVUS President reminded us, “People know that we know what we’re talking about.” So we need to get out there and share what we know!

We can start by supporting LWVC in **defeating** Prop 27 on the November ballot. Don’t be shy in speaking up against this initiative to gut voter-approved LWVC supported Prop 11 and eliminate the Citizens Redistricting Commission. LWVC was awarded the Strengthening Democracy through Reform Award at Convention 2010 for our success in putting together a successful coalition to give California voters back their voice in their own government through Prop 11. Since its passage in 2008, over 30,000 Californians have applied for the 14 member Commission. Remember: League speaks with one voice and on this issue our voice needs to be strong and loud. **Absolutely NO on Prop 27!**

Attending Convention 2010 as your delegate was enormously rewarding, educational and energizing. Join me and your Board in working towards more informed and active participation by the voters in our community. You can help with voter service where we provide nonpartisan information on both sides of an issue and offer forums to give candidates a chance to answer questions on those issues. NATIONAL

Two important issues are being considered in the Senate. The Disclose Act was passed in the House of Representatives and is due to be considered in the Senate. The LWV has been lobbying for the bill in the hopes that it will pass in time to influence the upcoming Congressional elections.

Comprehensive climate change and clean energy legislation will be brought to the Senate by the end of July.

STATE

The California LWV strongly supported the redistricting reform act (Proposition 11) that was adopted by California voters in November 2008. Before this act has been fully implemented, two new ballot propositions to change the process adopted by California voters have been placed on this November's ballot.

The reform act established a Citizens Redistricting Commission that will redraw district maps for the state legislature and Board of Equalization after each census.

Proposition 27 would completely eliminate the redistricting commission and return the redistricting authority to the legislature, resulting in more gerrymandered districts. The League strongly opposes this measure.

Proposition 20 would add the authority for redrawing Congressional districts to the Citizens Redistricting Commission. The League will announce its position on this measure soon.

The California LWV has taken stands on five other ballot measures for the November 2010 election. Read about these propositions the on the California LWV web site, www.lwvc.org.

LWVSC Partners with Groundswell on Land Use

The League of Women Voters of Stanislaus County is proud to be a new participant in the Groundswell (www.groundswellsjv.org) project, as approved by our Board during the July meeting. Groundswell, a non-partisan network of people and organizations committed to improving the quality of life in the San Joaquin Valley through better land use decisions, is managed by the American Farmland Trust and funded by a private grant.

As part of the LWVSC's participation, a profile of our organization will be listed on the Groundswell website. Additionally, our contacts will be notified via action alerts and an event calendar about pending land use policy decisions and other related issues so that we can mobilize our Local Action committee members to take action if needed.

Although the website's formal launch is scheduled for later this summer, you can visit the Groundswell site now to see what it offers. There are sections for each county in the San Joaquin Valley, with links to foundational planning documents, local public officials, and vital statistics; useful reports and studies on topics related to land use; a master events calendar; and more.

As an educational and networking tool, Groundswell will allow LWVSC to inform the community about ways in which citizens can affect land use policy through the local decision-making process. We're excited to be a part of this valuable project, which aligns perfectly with our local position on land use planning.

A meeting to study and recommend action on two proposed local measures on the November ballot is scheduled for Thursday, August 19 at 6:30 pm at the League office.

- The City of Modesto has placed a Charter amendment to change procedures for run-off elections for City Council and the Mayor.
- Residents of unincorporated Parklawn requested a Measure M vote to extend sewers to their neighborhood off Hatch Road.

The pros and cons of these measures will be presented along with relevant League positions.

All members are encouraged to learn about the measures and participate in the discussion.

State ballot measures concerned with redistricting - Propositions 20 and 27 - will also be discussed.

Tori Hughes, Patterson Police Chief

Law enforcement from the female perspective: That was the Sheriff's Lieutenant/ Patterson Police Chief Tori Hughes' topic at the July Lunch and Learn. (Patterson contracts with the Sheriff for its police services). Chief Hughes was motivated to pursue law enforcement as a career after a childhood experience when law enforcement was unable to help to her and her family. She wanted to change the perception of police officers. She brings a background of extensive training and varied experience to her latest responsibility.

Chief Hughes considers compassion and communication keys to her success. Yes, she had to prove that she could respond with force and give support to her male counterparts when necessary. But she also found she could "talk them into the handcuffs". Similarly, community policing, which emphasizes education and prevention, is successful because of the relationships established with local residents. Whereas academy training focuses on the law and physical skills, there is a need for officers to develop "Tactical Communication", a course she teaches.

She sees a need for more female law enforcement officers, but with layoffs and tight budgets, she doesn't see that happening soon. In the meantime, she acts as a mentor to female officers as they face the challenges of the male dominated culture of law enforcement

As chief, she maintains an open door policy for the officers and the residents. Her goal is to make any and all community contacts positive. She also strives to create a positive, supportive working environment for her officers. "A happy cop is a good cop."

Convention Action

It was exciting to be your delegate representing our League in program decisions for the next two years. Ours is a grassroots organization. Delegates, like me, representing Leagues, like ours, vote on what issues to study or emphasize. After much discussion, we adopted two new studies:

- 1) **The federal role in public education**, particularly policy-making, with possible consideration of funding, common standards and or governance relationships among all levels of government.
- 2) **Privatization**: the policy agenda to transfer government functions and assets to the private sector.

The scope of these studies is dependent on the ability to raise funds to support them.

You might remember that our League participated in the LWVUS study of the use of the National Popular Vote as a way to achieve the goal of direct popular vote of the U.S. President. We (LWVSC) voted in support of NPV but nationally leagues failed to reach consensus. At Convention, a grassroots effort led by LWV Arizona garnered enough votes to pass it by concurrence on the Convention floor. Having been the study chair for our League, I had a great time lobbying others at Convention. I wish some of my fellow study group members could have been there.

We also adopted an updated Arms Control Position by concurrence. This is a position that LWVSC members asked to be re-studied at past annual program planning meetings.
