### Message from our President, Mary Giventer:

Forty-seven years ago, Lyndon Johnson signed the historic Voting Rights Act into law. This law remains critical to ensuring that every American can cast a ballot and have it counted. In many states, the League is fighting to protect and defend voting rights. In California, we fortunately are not facing state voter suppression laws. Our challenge is to reach out to register new voters and to help all voters be informed. Even in a non-swing state like California, we are seeing attack ads. The job of the League is to help voters focus on the election and issues rather than the sound bites. This is more than a Presidential race. Congress, a third of the Senate, numerous local races and a wide array of initiatives are also on the ballot. The outcome of these races will have as much of an impact on our community, our jobs, our health and our future as the Presidential race. Through our voter service activities, we can give voters opportunities to get the facts on the issues and to hear directly from candidates running for office through forums, voter guides and Smart Voter. We can support our local media in fact checking independent political advertising. At the LWVUS national convention, political pollster Zogby stated that one factor in this year's election will be that many voters, especially young voters, have given up hope. Many of us, young and old, are disappointed and frustrated by the extreme partisanship that results in the negative tone of the campaigns and a deadlocked government. Our League President, Elizabeth McNamara, suggested that as League members we are in a position to help voters turn this frustration into the resolve to "not get mad, get out and vote". When we go to the polls in November the election is not about the day-to-day battles between politicians, it is about every voter standing up for what they believe in and making democracy work.

#### National Action:

The LWVUS has responded to the EPA call for public comments to its draft guidelines for the use of diesel in hydraulic fracking. The League's response is based on our long-standing national position on natural resources: Resources should be conserved and protected to assure their future availability. Pollution of these resources should be controlled in order to preserve the physical, chemical and biological integrity of ecosystems and to protect public health.

Review of the EPA's draft guidance documents prompted the League to respond not with recommendations per se, but with a series of questions that highlight possible problems and contradictions in regulation of this very complicated process and the far reaching consequences of its use. The detailed questions relate to providing consistency, safety and accountability for issuing of permits, regulating contamination and other effects of hydraulic fracking, and addressing the evolving nature of this fuel and the hydraulic fracking process. Reading the League's carefully crafted questions can give you insight into the nature of this energy source and for the expertise required in safe development and regulation of energy. #### State Action:

Vote YES on Proposition 30!

This measure ensures adequate funding for our schools and colleges, and will keep police and firemen on the job in our communities. The revenues cannot be diverted for other purposes, and will go into a special account that cannot be touched by the legislature or used for state bureaucracy.

The effect on most taxpayers will be minimal. The measure will increase the state sales tax rate by one-quarter cent per dollar for four years. The personal income tax will be increased for seven years only on taxpayers with an income exceeding \$250,000 for a single filers, or \$500,000 for couples filing jointly. This tax on personal income will affect only affect about 1% of California taxpayers.

Proposition 30, if approved, will provide additional revenue to help balance our state budget, and help to bring down our rapidly burgeoning debt. Without it, we will suffer devastating damage to our public education system and our local public safety departments.

Vote with the League! Vote Yes on Proposition 30!

Her 16-year history with the district also includes experience at the site level as a teacher, as a principal and in human resources and special projects at the district level. - V.P. Stella Beratlis reported that the consensus questions for the Initiative & Referendum Update Study are available on-line
- •Mary Giventer reported that the State LWV has formed a task force regarding the conversion to 501C3 (nonprofit status for Leagues) and hope to have a report for the November State Board Meeting. They have filed conditionally at this time to pave the way for Leagues who wish to pursue this option

# Modesto City Schools Facts and Forecasts

Pam Able, Modesto City Schools Superintendent, spoke to August Lunch and Learn attendees. She highlighted numbers that describe the district:

- 31,000 students (included 3,000 receiving special education services).
- 3<sup>rd</sup> largest employer in the county
- 7,800 students speak 40 languages (90% Spanish)
- 57% of students are Hispanic and 25% white
- 85% of K-6 students qualify for free or reduced lunch
- 2011 graduation rate of 76.1%
- 6,000 students are transported to and from school
- 24,000 meals served daily

To meet the challenges this diversity presents, the district has adopted the three Cs:

Communicate – with the community and within the district, Collaborate to get the work done and Celebrate achievements, then get back to work! Specific programs to create a positive learning environment and engage students include the various high school academies, a grant which funds a Community Outreach Coordinator to bring volunteers to the schools and parent training to encourage parents to become involved in their child's school.

Forecasts are directly related to the state budget. California is 47<sup>th</sup> in the nation for per pupil funding. MCS has not received more that \$175 million owed over the last five years and is looking to additional cuts if trigger cuts become necessary for 2013-2104. She discussed Props. 30 and 38. (League supports Prop. 30). Implications of reduced funding include fewer instructional days, layoffs and the "trickle down" effect on the community's economy. Supt. Able emphasized the need for an educated community so that individuals and the community can compete in the larger economy.

### From the Desk of the Vice-President:

#### **LWVC Initiative and Referendum Update Study**

As of March 2012, the number of initiatives targeted for the November 2012 ballot is huge: four have qualified, 67 have been cleared for circulation, and five are pending at the Attorney General's office. On average, 21 percent of proposed measures actually make it to the ballot, predicting 20 measures will be decided in November.

Had enough? During the May 2011 LWVC Convention, delegates adopted an update of LWVC's study of California's initiative and referendum process. The study committee is working to develop the material that all local Leagues in California will use to come to consensus at meetings later this year or early 2013–after the 2012 presidential election.

The Committee is examining history, process (including the practices of other states), and key concerns, sifting through dozens of ideas to reform California's process. They are seeking to identify the deeper policy-based issues that will help shape the League's position on California's initiative and referendum process in the future. The reform ideas being examined cover a wide range of possibilities, from throwing out the whole process as suggested by Peter Schrag in *Paradise Lost* to embracing the growth trend of direct democracy. Here are some of the more popular themes:

- Level the Imbalance of Money Interests
- Increase Transparency
- Engage Citizens
- Think Slowly; Work Together
- Technology Impacts
