# Local action committee following proposed Modesto developments and Measure M

Two development projects and a Measure M ballot measure will keep the LWVModesto Action Committee busy in the next few months. The Modesto City Council has recommended that a Measure M advisory vote for sewer extensions to the Robertson Road neighborhood, which is a county "island" within the city, be placed on the November ballot. The city and the county have been working together to find funding to bring the neighborhood up to city standards – starting with sewer service.

At the same meeting, the Council authorized an Environmental Impact Study for the proposed Promenade north of Vintage Faire. And at its July 19th meeting, the Modesto Planning Commission considered various zoning and planning issues for the Kaiser Medical Center proposal north of Modesto.

LWVM Land Use Position supports planning that protects the quality of our environment, is contiguous to existing development and provides adequate funding for infrastructure. We will study these proposals with these factors in mind. The Local Action committee meets at noon on the second Friday of the month at the LWV office, 720 13th Street. Interested persons are invited to attend.

# LVWUS supports renewal of assault weapons ban

In a letter to Members of the House of Representatives in May 2004, LWVUS President Kay Maxwell stated. "LWVUS believes it is critical that Congress act now to renew the federal assault weapons ban before it expires on September **12, 2004.**" League has a long standing position in support of the assault weapons ban. The ban instituted in 1994 has been effective: the number of assault weapons has declined as has the number of these weapons used in crimes.

"We believe that there are not legitimate protective, sporting or recreational purposes for these weapons," Maxwell stated.

Members are urged to contact their representative and President Bush to support H.R. 3831 to extend the assault weapons ban for another 10 years. Contact your representative on-line by going to House of Representatives.gov, enter your zip

code (including the 4 digit extension), and type your message.


# National non-profits partner with Advance America to register over 50,000 voters

SPARTANBURG, S.C., -- A coalition of seven prominent non-profit organizations are partnering with Advance America Cash Advance Centers, Inc. to conduct Register in Advance, a national non-partisan effort to register more than 50,000 new voters this election year. NFL running back Stephen Davis of the Carolina Panthers serves as honorary chair of the program, encouraging citizens to register to vote through public service announcements airing in markets nationwide.

The League of Women Voters, National Urban League, National Association of Latino Elected and Appointed Officials Educational Fund, People for the American Way Foundation, League of United Latin American Citizens, Southwest Voter Registration Education Project and the Georgia Coalition for the People's Agenda are providing grassroots support for the campaign, conducting voter registration drives and outreach activities across the U.S. Advance America, corporate sponsor for Register in Advance, is making voter registration forms and instructional materials available through September 18 in more than 2,000 Advance America locations in 29 states. During National Voter Registration Week, September 12-18, Register in Advance partners will draw national focus on efforts to register citizens for the 2004 general election.

Register in Advance began in 2002 as an unprecedented voter registration partnership between non-profits and the business community. That year, approximately 50,000 citizens became registered voters as a result of this endeavor. Advance America and its partners are aiming to exceed that number in this 2004 election year.

According to U.S. Census data, approximately 57 million Americans (roughly 30 percent of the U.S. voting age population) are not registered to vote. Attitudes about the power of voting, family and community influences, and difficulties in understanding the voting process are all barriers to more citizens actively participating in elections. Register in Advance seeks to break down those barriers through a sustained campaign that provides citizens with convenient access to voter registration forms, in English and Spanish, as well as the information they need to become registered voters.

# LEAGUE'S NONPARTISAN POLICY

The League of Women Voters of Modesto is nonpartisan. As an organization, it does not support or oppose candidates for public office, but acts only on those issues chosen by the membership for study and action.

The League believes that the political parties are essential to the American system of government and that the participation of informed citizens is beneficial to the political parties and to the system. Consequently, the League encourages its members as INDIVIDUALS to be active in the political parties, in finding and supporting the candidates for public office, and in seeking election to public office.

Members of the League are not eligible to serve on the Board of Directors while seeking or holding elective office. The President, Voter Service Director and Office Manager may not campaign for candidates as individuals, due to the visibility of their positions. It is the responsibility of the Board of Directors, collectively and individually, to insure that the community has no reason to question the nonpartisan position as an organization.

### SOUND MANAGEMENT PRACTICES RECOMMENDED FOR 2004

**WASHINGTON, DC-** The League of Women Voters of the United States (LWVUS) today issued a new report to help safeguard the votes of all Americans in the 2004 election. *Helping America Vote: Safeguarding the Vote* outlines a set of recommended operational and management practices for state and local election officials to enhance voting system security, protect eligible voters and ensure that valid votes are counted.

"Every community should have safeguards for voting systems so that they operate properly and accurately record the voter's intent," stated Kay J. Maxwell, LWVUS president. "In this report, the League has put together a list of common-sense practices that have proven effective in states that have already put them into use," Maxwell said.

"Many people don't realize that most voters coming to the polls this fall will cast their votes on the same type of voting machines they used in the 2000 elections," said Maxwell. "*Checklist for Voting Systems* – an easy-to-read supplement in *Safeguarding* – is a handy starting place for election officials and voters to ensure that all voting machines are ready for Election Day. This resource includes a simple list that applies to all voting machines and a specific checklist for each type of machine," Maxwell stated.

"No matter the voting machine being used – punch card or optical scan, lever or touchscreen – there are universal steps to be followed in preparing for Election Day," noted Maxwell. "All voting machines, for instance, should meet federal qualifications and state certification standards, and these should not be bypassed on Election Day. Ballot design for each type of machine is vitally important in making sure that voters properly cast their votes. And aggressive education efforts are essential to show voters how to use their voting machines," according to Maxwell. "The *Checklist* also provides basic measures for each particular type of machine so officials can tailor protections to their precinct or county," Maxwell stated.

"The League's report provides the tools – the nuts and bolts – to assist election officials in improving voting system security, ensuring that machines operate properly, and setting up voter registration systems that enfranchise, not disenfranchise voters," Maxwell said. For example, the report recommends "tracking and documentation of all procedures, from the testing of machines to the handling of ballots," to ensure that such practices are actually carried out and that audits are possible if problems occur.

"The League is known for working closely with election officials to make the system function better, and this report is part of our ongoing efforts. *Safeguarding* builds on the recommendations we provided officials in the first Helping America Vote monograph, *A Guide to Implementing the New Federal Provisional Ballot Requirement* (<u>http://www.lwv.org/elibrary/pub/voting\_help-vote.pdf</u>) in August 2003," said Maxwell.

"From now until well beyond Election Day, League members in communities nationwide will continue fighting for changes that protect eligible voters. Sound management practices will strengthen the election process and protect the fundamental right to vote," concluded Maxwell.
