### **Drive-Through Farming: exploring the links between transportation and land use**

**This is a membership recruitment event--come, and bring a friend who is interested in local development!**

Thomas Kronemeyer, a senior associate with Community Design + Architecture, will explain how transportation decisions affect land use and development patterns. The San Joaquin Valley can learn from the mistakes of Southern California and the Bay Area—or make the same mistakes and have the same results. Get a better understanding of how decisions made today can radically affect the future of San Joaquin Valley and the agricultural foundation of the region's economy, as well as the tradeoffs necessary to achieve a better future.

Can we build our way out of congestion? For answers, we should consider Los Angeles and the Bay Area. The West Coast was developed during the post-World War II era, when automobiles began to dominate transportation. The result has been sprawl, extermination of agriculture, some of the poorest air quality in the country, a dangerous pedestrian environment, and disenfranchisement of the young, the elderly and anyone else unable to obtain a driver's license and a car.

If we can't build enough roads to reduce congestion, what are our choices? We can look to places such as Boise, ID; Fresno; Sonoma County; Charlottesville/Albemarle County, VA; and

Portland, OR to see how to create more compact cities, preserve farmland, improves pedestrian activity and quality of life. The choices can create a city that everyone can enjoy, regardless of age or car ownership. These cities are not unusual, but the decisions made there have allowed them to develop in ways that enhance the lives of their citizens.

Mr. Kronemeyer has worked on multi-disciplinary planning and design teams, both in Germany and the United States. The design of pedestrian-oriented, livable places and the sensitive integration of new development into the fabric of existing built and natural environments are at the heart of his professional work and research. Mr. Kronemeyer's current work focuses on studies related to multi-modal transportation corridors.

### League Lauds New Presidential Public Financing Legislation

*League President Sees Reforms as Necessary Repairs for Ailing System*

Washington, DC- The League of Women Voters today applauded the introduction of presidential public financing legislation in the House and Senate and called upon lawmakers to fix our presidential system once and for all.

"The 2008 Presidential election is already dominating headlines—and candidates are asking supporters to open their checkbooks earlier than ever before," Mary G. Wilson, national League president observed. "League members and voters agree: we need public financing for presidential elections."

"Today's legislation aims at cutting the reins that big money and special interests have over presidential elections in this country," said Wilson. We need to have fair competition for votes, not a mad rush for big dollars. I encourage all members of Congress to support the Shays-Meehan-Price bill and make a real commitment to changing the way presidential elections are run."

The legislation, introduced by Reps. Meehan (D MA), Shays (R CT), and Price (D NC), as well as Sen. Feingold (D WI), increases the amount of matching funds for the presidential primaries, increases the spending limit for candidates choosing to participate in the public financing system, and moves the starting date for the payment of matching funds to primary candidates from January 1 of the election year to six months before the first primary. If passed, the legislation would go into effect January 1, 2009.

The League of Women Voters has long supported public financing for elections. In July 2006, the League joined other coalition partners in sending a letter to members of Congress, asking them to support a voluntary system of public financing and spending limits for all federal elections.

### **League Urges House Leadership to Seize Opportunity;**

#### ***Secure DC Voting Rights***

**Washington, DC-National League** president Mary G. Wilson today issued this statement strongly urging the House leadership and other members of Congress to take immediate action on D.C. voting rights.

"With new leadership in the U.S. House of Representatives, legislation to provide voting rights in the House for citizens of the District of Columbia, H.R. 328, has a real chance of passage on the House floor," said Wilson. "It is not only in the best interest of D.C. citizens, but in the interest of all Americans, that Congress strike while the iron is hot on this vital equal rights issue."

"We call on the Speaker and the Majority Leader to schedule the bill soon, before the spring recess and before the House is consumed in other business," she said.

Citizens of the District of Columbia pay U.S. taxes, fight and die for the U.S. during wartime, and are governed by the laws that Congress passes. And yet they have no voting representation in Congress. They have only a non-voting delegate in the House of Representatives. The League's Lobby Corps members have been meeting with members of Congress on this issue since the new session began last month. Tomorrow, February 15, is Congress Day 2007, an event in which elected officials and other citizen advocates walk the halls of Congress to educate members of Congress and their staff on the D.C. Voting Rights Act.

"Citizens will be carrying a very strong message to Capitol Hill tomorrow: it is time for Congress to right this wrong," added Wilson. "Only Congress can ensure that the democracy Americans have espoused and fought for across the globe becomes a reality in the nation's capital."

The "D.C. Fair and Equal House Voting Rights Act," sponsored by Delegate Eleanor Holmes Norton (D DC) and Representative Tom Davis (R VA), provides voting representation in the House for DC citizens by increasing the size of the House by two seats – one for D.C. and the other for the state of Utah, which is entitled to the next seat by size of population. This balanced approach provides voting rights for District citizens without upsetting the partisan balance of the House.


