League Takes Stands on Constitutional Issues

The League of Women Voters of the United States believes in the individual liberties guaranteed by the Constitution of the United States. The League is convinced that individual rights now protected by the Constitution should not be weakened or abridged.

Recently, LWVUS has taken stands on two Constitutional issues. As you know, LWVC Convention 2003 passed resolutions stating our concerns that the Patriot Act and Homeland Security Act (2001) undermine rights and civil liberties. Leagues throughout the country have held informational forums in their communities inviting representatives from the U.S. justice system as well as civil libertarians to explain the acts and answer questions. In July, LWVUS President Kay Maxwell sent letters to U.S. Senators expressing concern

about possible extension of the Acts' sunset and/or expansion. On September 10, President Bush proposed expansion of the Patriot Act's law enforcement powers, and on September 11 Mrs. Maxwell issued a statement urging "Congress to protect our homeland through means that protect our civil liberties rather than chipping away at the basic values for which America stands."

Campaign finance reform has been a high priority for League for many years. Though passage of the Bipartisan Campaign Reform Act (2002) was seen as a victory, implementation left much work to be done. 

Smart Voter: A Valuable Resource

Angela Keith and the Smart Voter committee are very busy getting Smart Voter operational for the November 4 election. Whereas in the past the County Elections Department has underwritten Smart Voter, the department is unable to do so because of state and county budget cuts. The League Board agreed that Smart Voter is an important resource to candidates and to voters that we do not want to lose in our county. The Board decided to move forward with Smart Voter using our own resources while continuing to seek financial support for the web site.

Candidates for all contested offices in the county have been invited to enter information about themselves and their stands on issues on the web site. For the first time, we have included issue related questions to be answered on line by candidates for Modesto Mayor, Modesto City Council and Modest City School Board of Education. We will continue to offer polling place information as well as access to voters' ballots specific to their address. The site also offers links to other interesting information related to the election.

Librarian Discusses Library Successes, Worries

You can feel the passion behind Vanessa Czopek's words when she speaks about our library system.

Her subject at the August Lunch and Learn covered library outreach services through the 13 library branches in our county. "Virtual Reference" has just come on line. But books are still the bedrock of all libraries; our last year had a circulation of two million. That doesn't count the wealth of other services: children's story hours, literacy classes, videos, computer access, special collections, and on and on.

More troubling to her and all of us is the USA Patriot Act (and its possible successor, Patriot Act II). Ms. Czopek spent most of her time detailing what its effects will be.

The Act gives "unchecked authority and sweeping unconstitutional powers" to domestic and international law enforcement. Just by claiming an investigation is related to terrorism, the FBI may get a search warrant to seize records of ANY person. No suspicion of criminal activity is required; no probably cause has to be shown.

Most frightening of all, the target person cannot be notified that they are under investigation. This has a chilling effect on citizens' right to read when government agents can spy on their reading habits. Our right to privacy is being invaded. OUR RIGHT TO PRIVACY IS ESSENTIAL TO THE EXERCISE OF FREE SPEECH AND FREE THOUGHT.

"All kinds of Americans are now waking up to the fact that the Patriot Act gives the government the right to put American citizens in prison indefinitely, without knowing the charges against them, without access to an attorney, without the right to confront their accusers, without trial." Closing this section of her talk, Vanessa Czopek quoted John F. Kennedy: "Let our patriotism be reflected in the creation of confidence rather than crusades of suspicion."

Vanessa also explained that internet filtering in public libraries is now a requirement for libraries to receive federal funds under the CHILDREN'S INTERNET PROTECTION ACT. The new law requires filtering software to block obscene or pornographic images in all computers (including those of the staff). Here's the rub: Filtering software companies refuse to disclose what sites they are blocking. Hate sites are NOT BLOCKED. But we do know that filtering blocks a significant amount of constitutionally protected speech.

Stanislaus County now filters computers in the children's department and children under 12 may not use the internet without a parent or guardian present.

Stanislaus County was the first in the state to pass the one-eighth cent sales tax exclusively for libraries, and it brought our library system back from (almost) the grave. It was thus a model for much of the state. Our League worked hard for its passage and will probably need to do so again unless the state passes something that will avoid the five-year "sunset" provision, which will come up again in 2005 for renewal.

The League has a strong position supporting full funding for libraries of excellent quality.

challenge: did Congress violate the Constitution by imposing tough new campaign-finance restrictions? LVWUS filed a "friend of the court" brief that asks the Court to uphold the legislation.

Both issues have significant political and Constitutional ramifications. Leagues at all levels will be monitoring these issues and voicing support for protection of Constitutional rights and liberties.
