Modesto City Water System to be Upgraded

A recent full page editorial in the Modesto Bee called attention to the fact that California is running out of water.

Two days later Peter Cowles, Modesto's Public Works Director. spoke to the League of Women Voters of big changes ahead for our water system.

For some years, all new development has been required to install water meters, and the development paid for them. But they haven't yet been read. In the near future, meters will be required by state law all over the city, though installing them in old neighborhoods remains a vexing and expensive problem. So we will have a big incentive to save water when that comes about, since everybody will be equal when everybody has a meter.

Along with this change, the MID and the City will be expanding the water treatment plant on the Tuolumne River

that already serves much of Modesto. Water pressure is falling on high-use water days and much of the infrastructure needs rebuilding. Plus, many wells are closed due to contamination (both

natural and man made). A water system must be built for peak use, not average, since water pressure immediately falls when the system hits over its peak delivery.

If passed, it will result in "considerable costs to urban water suppliers and ultimately to their customers, presumably offset, wholly or partially, by savings from water conservation." The recent news report that California might be experiencing a climate shift that may result in long-term consequences to our water supply adds to the concern for local water resources planning.

Last month we asked for help with researching SB999, which would have expanded and re-organized the San Joaquin Air Pollution Control District Board membership. We thank all who provided input, but we now know that the bill has been dropped by its author, Senator Machado.

We are rapidly approaching the November election and encourage all members to become actively involved in getting their friends, neighbors and acquaintances registered and to the polls. Remember: "democracy is not a spectator sport."

The present treatment plant was built with the Modesto Irrigation System and the city as partners in the 1980's and the expansion is planned for around 2008. The "footprint" of the second plant is already in place. Complicating this picture is the differential rate structure started when the city bought the old Del Este water system. The previous Council refused to raise rates, which were intended to be raised gradually. So to pay for the system, residents are in for a big shock in their water bills. The two systems have differing rates, which need in fairness to be equalized. Further complications: Modesto City water system also serves the communities of Waterford, Hickman, Ceres, Grayson, Salida, and the Del Rio area, all part of the old Del Este system.

Plus,

storm drains in the summer carry more water than they do in winter, unbelievable as it may seem, pretty much all due to overwatering those nice green lawns. A third complication is that Modesto wells are a super-fund site for cleanup due to a dry cleaning solvent plume infecting a number of wells. The city is involved in litigation over this problem.

According to

Proposition 218, a protest hearing is required in order to raise rates. THIS IS NOT A VOTE. All customers will get a notice and must return their notice to be counted. League members will recall that every state proposition has had "unintended consequences" and this is one of those things. Raising water rates and equalizing them over the entire city seems a no-brainer, but you never know how the City Council will vote.


