## Local Action Urges Measure M Vote

Our local action committee has determined that our local land use position warrants support of the November ballot "Measure M" votes. When sewer trunks are to be extended, Measure M requires an advisory vote. Areas proposed for extensions include 642 acres in an area called Johansen/Empire North, and 80 acres bordered by Pelandale, Tully, Carver, and Bangs.

Our land use position states that we support land use planning that protects farmland outside clearly defined urban boundaries to avoid unnecessary conversion of farmlands and planning that provides urban development contiguous with existing development where urban services can be provided. The areas slated for Measure M votes are inside the Modesto Urban Area General Plan and are already substantially surrounded by development.

The committee believes that the time has come for land use planning for these areas which will eventually be annexed to Modesto. This will be an opportunity for city leaders to require inclusion of low and moderate-income housing, something we will continue to promote based on our housing position. The committee will make League's support of these measures public by sending a letter to the Modesto Bee.

A delightful English woman finally understood. "Oh, that's like a vote of no-confidence."
