LWVSC Lunch & Learn, January 26th Bay Delta Water Quality Control Plan

Meg Gonzalez, Education Director from the Tuolumne River Trust, spoke at the January Lunch and Learn about water flows and salmon on the Tuolumne River. The river flows into the San Joaquin River and joins the Sacramento River at the Delta. A video highlighted the Delta as an ecosystem and the importance of adequate water flows to protect it. Less than 50% of the natural flow reaches the San Francisco Bay through the Delta because of upstream diversion. Eighty-percent of diverted water goes to agriculture and 20% for urban use. With the drought years, the slow moving, warm water flow has changed the chemistry and temperature of the Delta making it ripe for invasive species such as bass and water hyacinth, threats to salmon which require more and colder flows to survive, and encroachment of salinity in the Delta and surrounding soil.

The Trust holds that California water belongs to all of us, not just for our use but to also maintain the environment. Others claim historic rights to access river water for other purposes. The State can decide the best use for the water. The Bay-Delta Plan was to be reviewed every three years, but it has been more than 20 years since it was implemented. The State Water Resources Control Board (SWRCB) is now charged with developing a plan to improve the Delta's water quality and identify beneficial use for the water. Phase I focuses on the San Joaquin River Watershed, and Phase II will focus on the Sacramento River Watershed.

The SWRCB proposal is politically charged, especially in our area, becoming a fish vs. farmer or environment vs. people issue. Other steps are being taken to balance the divisive mindset. Conservation has contributed to increased flows. Though farmers and researcher are investigating more efficient ways to use water, Ms. Gonzalez suggested irrigation water is too cheap and does not incentivize farmers to improve efficiency (MID customers are charged 20% of the actual cost to deliver their water). Ms. Gonzalez suggested that the drought has bought these lingering issues to a head, and common ground is resulting from discussions among the stakeholders. Questions were posed about surface storage, California WaterFix (tunnels) and validity of studies on salmon and the rivers.
