President's Message: A Busy February

NEW MEMBERS WELCOMED. In the last year, LWVSC has gained more than 30 members! To welcome them and offer information about what League does and how it works, they were invited to a morning social in February. The event attracted 13 new members who enjoyed meeting one another over coffee and goodies and chatting with Board members. Each attendee received a packet with “the basics” about League – non-partisan policy, LWVC and LWVUS action position topics with website reference for details as well as our local positions. Laurie Carley explained how we can be a “nonpartisan political organization” and how we balance non-partisan education with issue-based advocacy. Julie Saugstad covered the process that League uses to adopt positions for advocacy that included examples of local actions taken. Invitees expressed appreciation for the opportunity to learn more about League and offered their personal areas of interest.

LWVC PROGRAM PLANNING. LWV grassroots in action! LWVSC members met at February Lunch and Learn to recommend topics for LWV California to emphasize in 2019-2021. Recommendation from all California Leagues will be reviewed and forwarded to delegates at the June Convention for action.

Our first task was to identify three important issues for future LWVC action. Consensus was reached on the following:

- Health Care with emphasis on programs to train and retain medical service providers in under-served areas, expansion of Medical mental health services, addressing the opioid crisis and preparing to meet women’s health needs should Planned Parenthood be defunded.
- Water: Continue the work of the LWVC Water Study Committee to review and update as needed the current LWVC water position to ensure it is balanced to meet the water needs of all Californians with regard to water management, usage, storage, quality, environment and conservation.
- AB 705 eliminates remedial courses at community colleges: advocate for programs to provide academic preparation so students can succeed at the community college.

- OTHER: Immigration, though our concerns (legal services, Dreamers, path to citizenship) would be better addressed at the national level.

Our second task was to consider proposals for consensus proposed by other Leagues.

- Approved a proposal from LWV Sacramento County to eliminate instant runoff as the preferred election process with a position that establishes standards and flexibility for local election procedures.
- Approved a new position on adult criminal justice with the suggested addition of provision for victims' rights.

Our third task was to review our local program for possible update. There were no recommendations for changes though it was noted that our positions on Adult Criminal Justice and Elections are consistent with those being recommended for adoption by LWVC.■
